

Form Creating a Designated Fund

______(Donor) hereby transfers as an irrevocable gift to The Greater Lynchburg Community Trust the sum of ______, or the property described in Exhibit A attached hereto and incorporated as part of this document, for the purpose of establishing a Designated Fund.

Net income alone shall be available for charitable purposes, subject to the schedule of fees adopted by The Trust for investing and administering the fund.

It is understood and agreed that the Fund and all funds therein are subject to acceptance by The Trust and shall be administered by The Trust subject to its "Amended and Restated Resolution and Declaration of Trust" including the power contained therein for the Board of Directors of The Trust to modify any restrictions or conditions if in their sole judgment such restriction becomes, in effect, unnecessary, incapable of fulfillment, or inconsistent with the charitable needs served by The Trust.

It is my desire that the bank to serve as Trustee of this Fund shall be determined by the Board of Directors of The Greater Lynchburg Community Trust.
